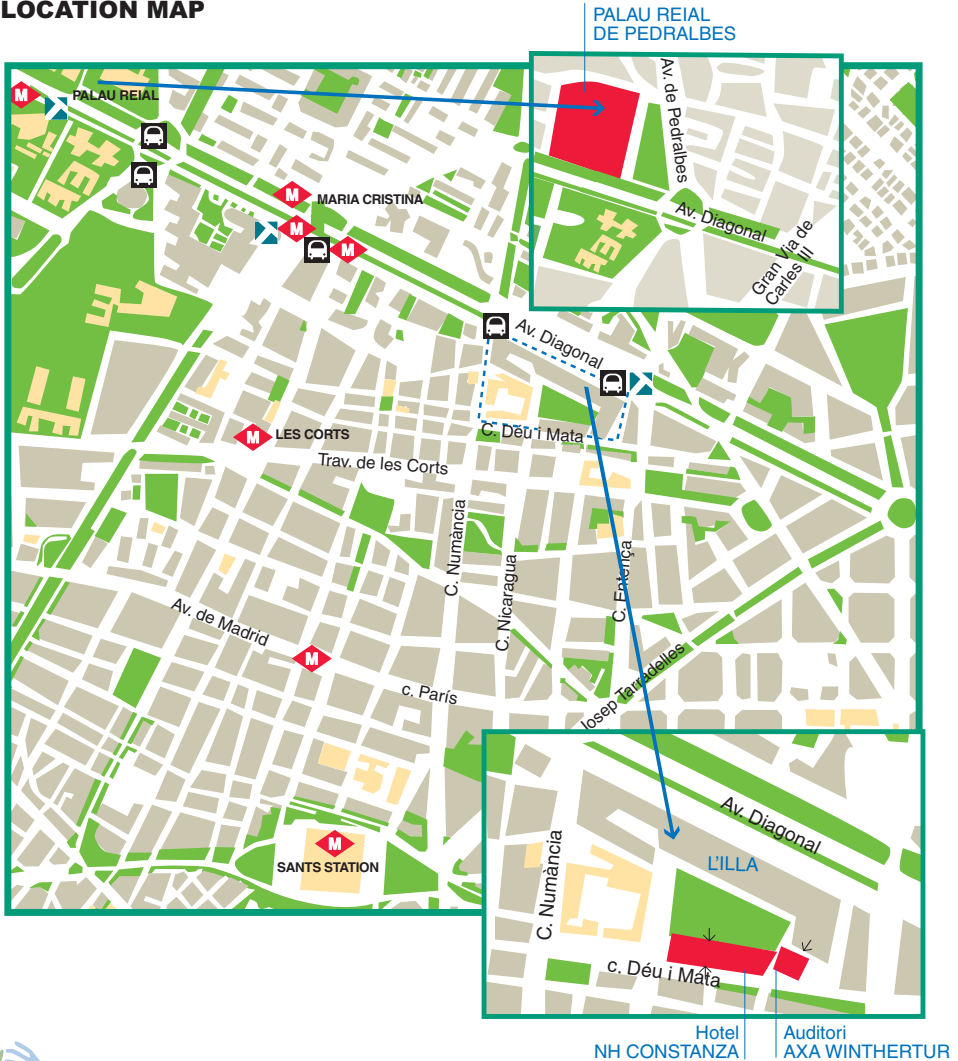
VENUE

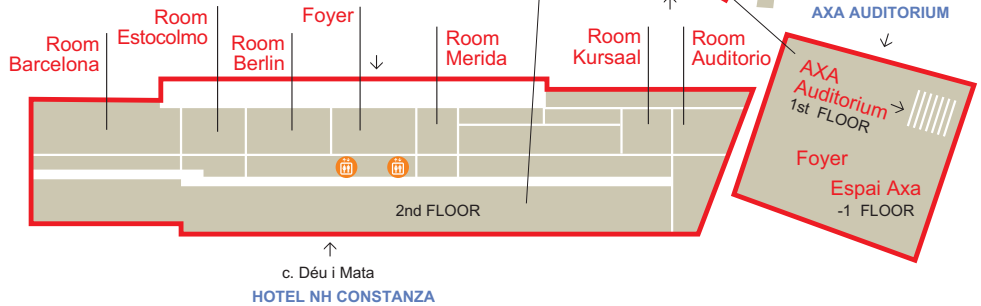
The newly built **Hotel NH Constanza**, where most of the parallel sessions will be held, is next to the conference centre.
